JOHN DORY'S TREASURE COMBO COMPETITION (TERMS AND CONDITIONS)

1. This competition ("the Competition") is conducted by John Dory's Advertising (Pty) Limited (referred to herein as "the Promoter") and may only be entered into by customers of John Dory's restaurants who are 18 (eighteen) years or older and resident in South Africa with a valid ID or passport.
2. Each entrant must be a registered holder of a John Dory's Club Card ("John's Club Card") or have a registered profile on the John Dory's mobile application ("John Dory's App").
3. No persons related to the Promoter may enter the Competition (including but not limited to their Subsidiaries and/or Franchisees) by way of being:
 - 2.1. directors, members, partners, employees, franchisees, agents of, or consultants to;
 - 2.2. any marketing service provider(s), any supplier(s) of goods or services, any other person who directly or indirectly controls, or is controlled by them; or
 - 2.3. any spouse, life partner, parent, child, brother, sister, business partner or associate of any of such persons.

These Rules may be amended by reasonable notification via the John Dory’s Facebook page at any time during the Competition and will be applied and interpreted by the Promoter and their decisions regarding any disputes relating to such meaning and/or content will be final and binding.
5. Participation by the entrants in the Competition constitutes an agreement to abide by these Rules.
6. Entries for the Competition will run from 08:00 on 06 August 2024 until midnight on 27 September 2024.
7. To enter and to be eligible, entrants must order a Hake & Prawn OR Surf & Turf meal (both referred to as a “Treasure Combo”) at a participating John Dory’s outlet and swipe their John’s Club Card or use the John Dory’s App when making payment.
8. If more than 1 (one) Treasure Combo purchased on 1 (one) invoice and 1 (one) John’s Club Card is swiped or 1 (one) John Dory’s App is used, the associated member will receive an entry for each Treasure Combo meal listed on the invoice.
9. If more than 1 (one) John’s Club Card or John Dory’s App member each purchased a Treasure Combo on 1 (one) invoice, then a different John’s Club Card or John Dory’s App may be used in respect of each Treasure Combo purchased, however, no more than 5 (five) John’s Club Cards or John Dory’s App memberships may be used collectively per invoice. For example, a maximum of 5 (five) could be collectively comprised of 2 (two) Johns Club Card swipes and 3 (three) John Dory’s App submissions.
10. The Promoter will not accept responsibility for entries that are lost, mislaid, damaged, undelivered or delayed in transit, regardless of cause, including, but not limited to, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
11. The Promoter reserves the right to disqualify any participant who breaches any provision of these Rules.
12. 20 (twenty) winners will be drawn at random at the end of the Competition based on their valid entries.

13. The prize for each winner will be 1 (one) of 20 (twenty) John Dory's e-Gift vouchers to the value of R1000 each.
14. The prize will under no circumstances be handed over to a third party and will only be handed directly to the verified prize winner or at the prize winner's written instruction.
15. The prize cannot be redeemed for cash.

- 18.2. The entrant agrees to give (where applicable) honest, accurate and current information about the entrant to the Promoter and to maintain and update such information when necessary.
- 18.3. The entrant's personal information collected by the Promoter may be used for the following reasons:
 - the processing of personal information on the Promoter's website;
 - further processing by third parties, including the fact that related parties of the company may access information on the Promoter's website;
 - direct marketing;
 - fraud prevention; and
 - SARB and SARS reporting and the like if applicable.
- 18.4. The entrant acknowledges that any information supplied to the Promoter is voluntarily.
- 18.5. By submitting any information to the Promoter in any form the entrant further acknowledges that such conduct constitutes an unconditional, specific and voluntary consent to the processing of such information by the Promoter under any applicable

law in the manner contemplated above, which consent shall, in the absence of any written objection received from the entrant, be indefinite and/or for the period otherwise required in terms of any applicable law.

- 18.6. Unless the entrant has consented, the Promoter will not sell, exchange, transfer, rent or otherwise make available any personal information about the entrant (such as name, address, email address, telephone, or fax number) to other parties and the entrant indemnifies the Promoter from any unintentional disclosures of such information to unauthorized persons.
- 18.7. Should the entrant believe that the Promoter has utilised the entrant's personal information contrary to applicable law, the entrant shall first resolve any concerns with the Promoter. If the entrant is not satisfied with such process, the entrant has the right to lodge a complaint with the Information Regulator of South Africa.
19. The winner will be required to forward a certified copy of their Identity Document and details of their address to the Promoter within the time period stipulated by our call center agent. Every reasonable effort will be made to contact the winner, however if the winner does not respond to the notification/s and/or provide the required documents within 3 (three) days after our call center agent has informed him or her that he / she has won the prize, failing which the winner will forfeit the prize and the Promoter will be entitled to redraw to find an alternative winner.
20. The prize is not transferable or exchangeable to the maximum extent permitted in law, the Promoter and its subsidiary and holding companies are not liable for any defects in, or changes to, any part of the prize.

In the event of any act of God, strike, war, warlike operation, rebellion, riot, civil commotion, lockout, combination of workmen, interference of trade unions, suspension of labour, fire, accident, or (without regard to the foregoing enumeration) of any circumstances arising or action taken beyond or outside the reasonable control of the Promoter preventing them from the performance of any obligation to an entrant (any such event hereinafter called "Force Majeure") then the Promoter shall be relieved of all such obligations to the entrant during the period that such Force Majeure continues and shall not be liable for any delay or failure in the performance of any obligations or loss or damage which the entrant may suffer due to or resulting from the Force Majeure.
24. The Promoter reserves the right to cancel, suspend, amend, or terminate the Competition at any time and without notice to the Participants.
25. In the event of a dispute in respect of any aspect of the Competition, the Promoter's decision is final and binding and no correspondence will be entered into. In the event of a dispute regarding a winner chosen in accordance with 12 above, the decision of an independent admitted attorney duly appointed by the Promoter will be final and binding and no other correspondence will be entered into.
